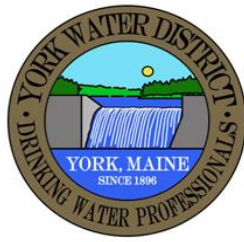

TO THE CUSTOMER

The York Water District has filed revised rate schedules with the Maine Public Utilities Commission to become effective January 1, 2018. This filing is made pursuant to 35-A M.R.S.A. Section 6104. The District shall hold a public hearing on November 8, 2017 at 5:00 – 6:00 P.M. at the York Public Library Conference Room, 15 Long Sands Road, York, Maine.

The District’s last rate increase became effective January 1, 2015. While the District has made several efficiencies, the increased costs for staffing, fuel, power, chemicals, and water storage tank repairs necessitates the proposed overall increase of \$152,919.

Proposed:

*Public Fire Protection charges are determined pursuant to Maine Public Utilities Commission Rules.

Pursuant to 35-A M.R.S.A. Section 6104, customers have the right to request additional information relating to the present and proposed rates from the Water District and the right to an open and fair hearing before the District. The Public Advocate Office may be available to assist customers in this matter. Customers also have the right to petition the Public Utilities Commission requesting that it suspend and investigate the proposed rate increase pursuant to 35-A M.R.S.A. Section 310 and 6104. The petitions must be filed with the Treasurer of the District and the Public Utilities Commission within 30 days of the public hearing and must be signed by at least 15% (approx. 823) of the District’s customers. Signatures on the petitions are invalid unless accompanied by printed names and addresses of the signers. Only one adult per household or account will be counted. Upon request the District will provide customers with petition forms that include spaces for the printed name and address of the signer.
